

SS&C | Blue Prism “Boundless Together: Celebrating 5 Years of Community” – Terms and Conditions

These terms and conditions apply to the SS&C Blue Prism “*Boundless Together: Celebrating 5 Years of Community*” series of activities (the “Competitions”), outlined below.

1. **Promoter and prize provider.** The promoter of the Competitions and prize provider is SS&C Blue Prism Limited of 2 Cinnamon Park, Crab Lane, Fearnhead, Warrington, England, WA2 0XP, with registered company number: 04260035 (“Blue Prism”).
2. **The Competition.** The title of the Competitions is the “*Boundless Together: Celebrating 5 Years of Community*”.
3. **Eligibility. NO PURCHASE NECESSARY.** The Competitions are open to all community members participating in the SS&C Blue Prism “*Boundless Together: Celebrating 5 Years of Community*” series of activities, being hosted and promoted on community.blueprism.com from the 18th of June, to the 18th of July 2024, aged 18 years or over, excluding: (a) employees of SS&C Blue Prism or its affiliated companies and individuals with an offer of employment from SS&C Blue Prism or its affiliated companies, (b) employees of agents or suppliers of SS&C Blue Prism or its affiliated companies, who are professionally connected with the Competitions or its administration, and (c) members of the immediate families or households of those identified in (a) and/or (b). Once that submission limit has been reached, you may still submit your video in the allotted time, but will not be entitled to a prize. All entries must be received by SS&C Blue Prism by the Closing Time. Entries received after the Closing Time are automatically disqualified. SS&C Blue Prism reserves the right to disqualify any entry at its absolute discretion. To enter the Social Media Competition, you must leverage elements from the Digital Toolkit provided on community.blueprism.com as part of the *"Boundless Together: Celebrating 5 Years of Community"* activities and post content on social media, while tagging our official channels and handles. SS&C Blue Prism will not accept: (a) responsibility for posts that are lost, mislaid or delayed, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, network, server, computer hardware or software failure of any kind; or (b) proof of transmission as proof of receipt of entry to the Competition. i The 20 winners of the prize will be handpicked and selected by members of the SS&C Blue Prism Customer Experience team, among the 50 entries within the Submission Limit. Winners

ii Every other eligible submission received within the Submission Limit will be eligible for the 10 USD gift card.

One like or comment will be equivalent to one engagement. Winners will be contacted using the details held by SS&C Blue Prism.
